#### THE INFIGHTING AND LAWLESSNESS CONTINUE:

The incursion strategy by Prime Minister Thomas, Finance Minister Burke and Information Minister Noel into certain targeted constituencies of the NDC seems to have fuelled further fire that has now led to an open revolt within the Party representing different forces. What is important to recognize and understand is that the party revolt touches deeply on Thomas's inability to lead a government that can bring about the much needed economic change that is desperately required in Grenada. So rather than the government concentrating on national economic development strategies, Thomas and his selected inner disciples are engaged in outing fires while the bawling of the nation continues to be ignored by the NDC government. IT IS A TRAVERSTY CREATED BY THE TILLMAN THOMAS WRECKERS.

#### FORMER TOURISM MINISTER DAVID RESIGNATION:

The long and persistent rumours about Minister David's unhappiness in the Tillman Thomas Cabinet came to fruition on May 2,2012 when he tendered his resignation as Minister of Tourism, Culture and Civil Aviation. It is important to point out that while David has resigned from the Cabinet, he maintains membership in the NDC where he holds the position of General Secretary.

During his press conference, he was asked about his NDC membership and party status to which he proudly responded that his resignation was from Cabinet and not the Party. Given his continuing affiliation within the dying NDC, it will be interesting to see which way he votes when the no-motion confidence calls for a vote that will determine the future fate of the Thomas administration.

There are many scenarios being bounced around since David's resignation. However, one likely speculation exist that since David cannot challenge Thomas for the leadership given the NDC constitution, he might be prepared to support the no-confidence motion that would see Thomas fall. If this occurs, it is likely to open up the leadership vacancy in the NDC which David yearns to achieve. Stay Tuned.

#### ARLEY BITS THE DUST: AMBASSADOR NOW?

Former Junior Minister of Culture, Senator Arley Gill became a political casualty after the resignation of David. His apparent fall from grace was triggered by three factors.

- 1) Prime Minister Thomas desire to give Dr. George Vincent a Senatorial appointment that would eventually lead him to assume the Tourism Ministry. Thomas had very little room for creating Senate vacancy. One other, Thomas's motive has been his disgust with Gill who as PRO of the NDC continues to dance with the leftists in the party.
- 2) Thomas might have been told that there is need for greater focus on the boundary delimitation issue, Comrade Clouden who was previously appointed by David as Maritime Ambassador might have lost his spark after being humiliated by Ambassador Cohen coupled with his bad mouthing of the NDC.
- 3) PM Thomas had to find something for Arley and given that he is the only other lawyer with post graduate studies in Law of the Sea, it was quite possible to give him an Ambassadorial position. However, to make a long story short, Arley's future depends on Thomas as he can pull the Ambassadorial plug anytime. Therefore, Arley should not look at his Ambassadorial appointment as scouring points. He still has to walk a fine line and the incursionists hope is that Arley will soon abandon David. In the meanwhile, there will be no comment from the Oceanographic Ambassador.

- Who will he be accredited to?
- ➤ What is the future of humiliated Attorney Anselm Clouden who was earlier named Ambassador for Maritime Affairs and was part of the Grenada delegation that coughed up the Boundary delimitation agreement.

#### **ACTING LABOUR MINISTER GLEN NOEL BOOED AT THE STADIUM:**

The May Day shouting and booing of Acting Labour Minister Senator Glen Noel is yet another confirmation that Grenadians have reached to the end of the jetty with PM Thomas and his disunited group. I hoped that good government common sense will prevail and Thomas will prevent disgruntled voters from jumping over. The Prime Minister and his inner crew should have predicted an unfriendly welcome given Noel's mischievous activities against the other faction within the NDC and his revelation that there are certain members seeking to remove the Prime Minister from power.

Booing a government Minister is a definite sign of national discontent and unfortunately Noel was the recipient of such nationwide disgust. It is only hoped that Thomas was told the truth thus allowing him to get a better understanding about the growing discontent in the country.

### NNP NO -CONFIDENCE MOTION IS NECESSARY FOR A NATIONAL DEBATE ON THE DECAYING POLITICAL SITUATION IN GRENADA:

In 1998, her long commitment and enthusiasm for health sector transformation in Grenada saw her demitting the position at the General Hospital and entering the political arena. She was appointed to the Senate and became Junior Minister of Health. Her transformation journey continued as she felt her vision for health could be realized by being an integral part of the decision making process.

In the 1999 general elections, she became the New National Party (NNP) candidate for the Parish of St. Marks and handsomely won the constituency. She was then elevated to the cabinet position of Minister for Health and The Environment where her dreams became a true reality and her efforts are well known throughout the state as Health and Environment Minister. These include:

- Construction of the new Grenada General Hospital with support from Cuba and Venezuela.
- Implementation of the HIV/AIDS world Bank project;
- Implementation of the St. George's University and Government of Grenada Cardiology Program;

In 2003, she was re-assigned portfolio and became the Minister of Communication and Works and continued her relentless effort in Nation building. Construction of bridges and roads; rural medical facilities; police stations; schools and child development centres.

In 2007-2008, Dr. Modeste-Curwen also held the Ministry of Tourism portfolio. During her short tenure as Minister, she continued the work which of her predecessors which resulted in many development projects coming on stream. Grenada has been recognized internationally and given acclamation for improvements in several key areas including the establishment of the world renowned Port Louis Marina.

Apart from her glowing contribution to the social, economic and cultural contribution to Grenada, she has also found time to remain engaged in civil society and philanthropic initiatives which include some of the following:

Participated in a study with Dr. Peter Bourne of SGU to assess the benefit of implementing a visiting Cardiology program in Grenada:

Researched and produced educational pamphlets on prevention of blindness, diabetic retinopathy and Glaucoma.

Recipient of the Caribbean Council for the Blind (CCB) award for outstanding services to the people of Grenada, Carriacou and Petite Martinique in the prevention of blindness.

Young offenders and the Law

The latter is an initiative aimed at finding alternatives solutions for teenaged offenders instead of sending them to Her Majesty Prison

Dr. Modeste-Curwen serves the Constituency of St. Mark in a committed and distinguished manner. Her ongoing work with various community groups, including the St. Mark Development Committee, with which she partnered to implement the nationally- recognised Sunset city food festival, has brought significant benefits to the Parish. #### NEW UNITED STATES AMBASSADOR TO BARBADOS AND THE EASTERN CARIBBEAN



Larry Palmer, appointed U.S. Ambassador to Barbados and the Eastern Caribbean

The United States has appointed Larry Palmer as its new ambassador to Caribbean island nations of Barbados, St. Kitts and Nevis, Saint Lucia, Antigua and Barbuda, Dominica, Grenada, and Saint Vincent and the Grenadines.

Palmer, a career member of the Senior Foreign Service, served previously as ambassador to Honduras, where he served until July 2005. He was then named president of the Inter-American Foundation, an independent agency that provides grants to Latin American communities to foster economic development, serving until June 2010.

The son of a minister, Palmer was born in Augusta, Georgia, and graduated from T.W. José High School as valedictorian in 1966. He earned a scholarship to Emory University and graduated with a B.A. in history in 1970. Shortly after graduating from Emory, Palmer joined the Peace Corps and served as a volunteer in Liberia from 1971 to 1973, teaching high school biology, science, chemistry, physics and American literature. Back in the U.S., he received an M.Ed. in African History at Texas Southern University in 1973, and then began an academic career as assistant director of financial aid at the University of Virginia from 1973 to 1974.

He served as vice consul at the embassy in Santo Domingo, Dominican Republic, from 1982 to 1984, and then as personnel officer at the embassy in Montevideo, Uruguay, with concurrent responsibility for personnel posted to Asuncion, Paraguay, from 1984 to 1986. Returning stateside in 1986, Palmer served as staff assistant to the Assistant Secretary for African Affairs from 1986 to 1987, and then served a tour in Africa as counselor for administration at the embassy in Freetown, Sierra Leone, from 1987 to 1989. Palmer served as ambassador to Honduras, until July 2005. He was then named president of the Inter-American Foundation, an independent agency that provides grants to Latin American communities to foster economic development, serving until June 2010.

Palmer will be the first Foreign Service officer to serve in this post at Embassy Bridgetown since President Jimmy Carter sent Frank V. Ortiz, Jr., in 1977.
